- 5. Proposed Outreach Items for the FY 2024-2025 Annual Budget
- a) <u>\$300.00 bus benches</u> (Attachment D) <u>Deferred</u> following a brief discussion.
- b) **Trifold brochure** for new residents (Attachment E)

i. Motion to approve \$330 including taxes for <u>1,000 "handouts"</u> without mailings <u>passed</u> as <u>moved</u> by Gros and <u>seconded</u> by Smith.

ii. Additional Motion to approve \$700 for mailings to <u>only the new residents</u> in our neighborhood, welcoming them and encouraging them to get involved, for this calendar year, <u>passed</u> as <u>moved</u> by Gros and <u>seconded</u> by Smith.

- c) <u>Motion</u> to approve \$200.00 for 8 foot table cover (Attachment F) <u>passed</u> as <u>moved</u> by Smith and Mann.
- d) **\$500.00 for a BABCNC pop up tent (Attachment G) Motion to amend** from \$500 to **\$1,200.00** was **approved** as moved by Gros and Mann.
- e) <u>Motion to approve banners</u> for <u>\$1,256.76</u> including tax to include: \$900 for banner relocation; \$97.50 (plus tax) to replace one damaged hardware; \$250 for permit processing cost was <u>approved</u> as <u>moved</u> by Smith, <u>seconded</u> by Mann. (Attachment H)
- f) <u>Additional motion</u> to measure effectiveness of our outreach activities by asking subscribers when they subscribe how they heard about us, e.g., a neighbor, trifold, mailer, event, banners, etc., so we have data on what is effective, passed as <u>moved</u> by Gros.
